ATTENTION: CRAFT VENDORS!

The Malad Valley Welsh Festival is seeking vendors of good quality ARTS AND CRAFTS for the two-day Festival in Malad, Idaho. Arts and crafts do not have to be Welsh in design.

CRAFT BOOTH FEES ARE \$30 again this year. **If we provide the awning there will be an additional \$5 awning fee.** If you choose to bring your own awning it must be 10' x 10'. Please read the entire application and return the signed form with your booth fee no later than **June 10, 2017**. We have limited booth space this year so booths will be awarded based on the first applications turned in with payment. Review of applications will be ongoing, and you will receive word by June 17 if you've been selected as a vendor. If your booth is not selected, your fee will be refunded minus a \$5 fee. We are hoping to not duplicate products this year; if more than one vendor applies to sell the same thing, only one will be selected.

YOU KEEP ALL BOOTH PROCEEDS. Only a limited number of booth spaces are available, so apply early. We anticipate about 1,000 visitors to the Festival.

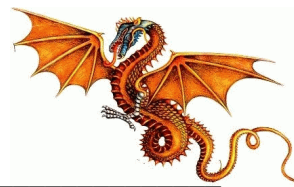

- Craft booths must be open during the following hours:
Fri, June 30, from 11:00 a.m. – 6:00 p.m.
Sat, July 01, from 10:00 a.m. – 5:00 p.m.
Vendors may set up as early as 9:00 a.m. on Friday and may stay open as late as 8:00 p.m. on both days. Failure to be open during the required hours may result in the vendor not being considered the next year.
- All products for sale must be high quality, and under the vendor's control.
- Any products not described in this application or that do not meet the standards of the Welsh Festival will be disallowed.
- No food items may be sold in the arts and crafts vendor area. (A separate application is required for food.)
- A booth space is 10' x 10'. A limited number of awnings will be available at a **\$5.00 fee**, but vendors are encouraged to bring their own awnings that comply with Festival specifications. **THIS IS A CHANGE FROM PREVIOUS YEARS.** Vendors who wish to bring their own awnings/tents/trailers must consult with the craft vendor coordinator (Roxanne Albretsen at 208-604-1234 or 208-766-4777 ext 146).
- **Vendors must bring their own tables, chairs, signs, and display boards.**
- All advertising and signs must be confined to the booth area. Every booth must have a sign large enough to read from at least 50 feet away. (Advertising brings customers!)

- Only two vendors may share a booth space.
- Vendors must comply with all applicable state and federal tax laws.
